In 2020 WaterStep (WS) impacted 1.3 million lives by providing access to safe water, sanitation and health education, bringing our grand total to just over 4.2 million lives served. We did this with support of hundreds of volunteers, many working from their homes due to the pandemic. In 2020, WS deployed 562 pieces of equipment in 23 countries. We had 22 international field consultants working on 347 water and/or disinfectant projects around the globe. This included deploying 108 BleachMakers in and around Louisville KY to fight Covid19. We responded to several disaster situations including providing over 100,000 gallons of safe water to a base camp in Lake Charles, LA, after the devastation by Hurricane Laura. Despite the "shelter in place" recommendations due to Covid19, our Community (continued on Schedule O)
