WE CONDUCTED TRAINING FOR 254 INDIVIDUALS, 146 OF WHICH WERE VIRTUAL, TO EXTEND OUR IMPACT AT REDUCED COSTS. WE INCREASED OUR ACTIVE INTERNATIONAL PARTNERS FROM 3 TO 17, WITH 70 ACTIVE PROJECTS IN 2016. WATERSTEP SERVED 343,000 INDIVIDUALS PROVIDING SAFE WATER, 206,000 OF WHICH WERE CHILDREN, A 110% INCREASE OVER THE PREVIOUS YEAR.
